This notification supersedes all earlier notifications related to the matters mentioned below.

- 1. There has been a revision in the terminology used for result statuses, the result statuses will be updated as follows:
 - "PASS" will now be referred to as "Qualified ".
 - "FAIL" will now be referred to as "Not Qualified ".
 - "ATKT" will now be referred to as "Qualified with ATKT".

Above result statues will be updated on applicable marksheets.

- 2. Marksheets for backlog examinations will only be issued after a student has passed all courses of the semester.
- 3. Remedial examinations will follow a descriptive format instead of the objective pattern.
- 4. All backlog End Semester Exams and Re-Exams will be combined with the regular end-semester exams and Re-Exams. Please take note of the following important points:

Winter Semester (Odd Semester) Courses:

If student is having backlog exams for Winter semester courses, it will be conducted along with the regular Winter semester exams.

Summer Semester (Even Semester) Courses:

Backlog exams for Summer semester courses will be conducted along with the regular Summer semester exams.
